

Pursuant to Section 9 of its General Terms and Conditions of Transportation Service, Dominion East Ohio is offering Firm Receipt Point Option capacity at the following pipeline interconnects for service beginning November 1, 2014:

Limited Firm Receipt Point Option capacity is available at each delivery point. Dominion East Ohio will accept bids at the delivery points for the following terms:

Delivery Point Name	Available Term(s)
Augusta/Carroll County	Annual Winter-Only (Nov-Mar)
Convoy (West Ohio)	Annual Winter-Only (Nov-Mar)
Maumee	Annual Winter-Only (Nov-Mar) Winter-Only (Nov-Mar) Temperature Sensitive* Peak Winter (Dec-Feb)

* Winter-Only Temperature Sensitive capacity will be reduced as temperatures increase. The following table will be used to determine the amount of capacity that can be utilized on a given day:

Target Temp F	Receipt Point as a Percentage of Purchased Firm Receipt
> 50	0%
40-49	50%
20-39	75%
< 20	100%

For example, if you bid and are awarded 1,000 dt/d of Winter-Only Temperature Sensitive Maumee capacity, and the forecasted temperature is 45 F, you will only be allowed to flow 500 dt/d. Charges for firm receipt capacity awarded under this level of service will be billed only for the amount of capacity allowed to flow.

Requests for Firm Receipt Point Option capacity must be accompanied by a bid. The deadline for bid submission is 5:00 p.m. Eastern Standard Time on August 29, 2014. Interested parties should submit bids by sending an email to: EOG_Trans_Serv@dom.com

Bids must specify the following information:

- Delivery point name
- Term (e.g., Annual, Winter-Only, Peak-Winter, or Winter-Only Temperature Sensitive)
- Requested maximum receipt volume (MMBtu/day)
- Firm receipt point surcharge bid (\$/MMBtu)

Dominion East Ohio is willing to identify winning bidders to enable other marketers and/or end-users to inquire about potential releases of capacity from time to time. In your bid, please indicate whether you would like Dominion East Ohio to post your supplier name on its EBB as a holder of Firm Receipt Point capacity in the event you are awarded capacity.

Multiple bids may be submitted as long as each bid "stands alone" and contains all of the required information. Dominion East Ohio reserves the right to refuse any and all requests. All bidders shall be notified concerning the acceptance or dismissal of their bid by 5:00 p.m. Eastern Standard Time on September 12, 2014. Submission of a bid by a customer and acceptance of that bid by Dominion East Ohio shall constitute a binding agreement whereby Dominion East Ohio shall render, and customer shall pay for, the requested service at the delivery point, term, volume and price contained in the bid.
